#### WATER EFFICENCY

We are seeing and hearing of shareholders who are being innovative in managing irrigation on their properties such as the Subsurface Drip Irrigation install at Maniototo Dairy.

MIC in partnership with ORC are planning a Bucket Testing Workshop for March. This will teach you how to test the spray irrigation on your property for efficiency. Further info to come once finalised.

A reminder to everyone to be mindful of where you are spraying water, please remember to turn off end guns near roads, also careful placement of K-Line to avoid watering roadsides or areas that are inaccessible.

## ORC LAND AND WATER REGIONAL PLAN CONSULTATION MEETINGS

Thank you to those that attended the FMU meeting for the Taieri at the Ranfurly Golf Club prior to Christmas. It was an interesting process that presented those in attendance with some challenging statements to demystify about land and water use on Otago farms in the future. We hope that the ORC team have listened carefully to your concerns and will action this feedback when creating their policy draft. We encourage you all to fully engage throughout this process while we are still able to influence the direction.

Following the FMU meetings Jeremy and Renee attended the stakeholder workshops held in Dunedin the two weeks leading into Christmas. These were broken in to five full day workshops: Flood protection, drainage, and river management activities, managing activities on the beds and Margins of lakes and rivers. Environmental flows/levels, damming & diversions, takes and use of water, and farming activities (including irrigation use). These meetings enabled us to have an opportunity to articulate the impracticalities for farmers and water users and offer alternative approaches. DRC is focused on providing a meaningful consultation process before the plan is built. The planning team have emphasized they are not experts and therefore want to hear from water users.

## **REMINDERS FROM THE RACEMEN**

A few irrigetors are having issues with their meters recording accurately, if you discover this, it is your responsibility to contact your Raceman or Jeremy as soon as possible. We will get a check carried out by Hervest and if this is given the all clear it is a requirement for you to have your meter checked and verified for its accuracy. Once this is done, please let your Raceman know or your water take for the period could be calculated incorrectly.

## MINIMUM FLOW AT WAIPIATA

MIC has an obligation to uphold a minimum flow below the Paeura weir of 8501/s, as well as 0001/s at Waipiata. Currently there is little gain being created between these two spots. Ma stem users are all turned off and will be until a significant change occurs. MIC have an dditional consent condition that states we do not need to meet 1.000 1/s at Waipiata if the de is below the reised height, however out of good will and for the health of the river we are releasing an additional 2501/s to uphold Waipiate as close to 1.000 as possible.
